NOTES

The requirements for a completed application include:

- 1) Sketch of site plan indicating building locations and fence details (including height and type (i.e. board, chain link, etc.))
- 2) Fee in the amount \$75.00. Payable by cash, debit, or cheque made out to the Township of Asphodel-Norwood
- 3) Written authorization from the owner of the subject land, if applicable.

By-Law 2018-55 excerpt

Residential Fences

No person shall have, erect, construct, maintain or permit to be erected, constructed or maintained a fence on a lot in a Residential Zone except in accordance with the following regulations:

- a) A fence erected within a rear or side yard shall not exceed a height of 2.0 metres (6'-6")
- b) A fence erected near a water body shall not exceed the height of 1.2 metres (4'-0") where the fence extends beyond 9.1 metres (30') from a residential building.
- c) A fence erected in a front or exterior side yard shall not exceed 1 metres (3'-3") in height when constructed of solid materials and does not exceed 1.2 metres (4') in height when constructed of open materials.

Non-Residential Fences

No person shall have, erect, construct, maintain or permit to be erected, constructed or maintained a fence on a lot in a non-residential Zone except in accordance with the following regulations:

- a) The maximum height of a fence located in a non-residential Zone is 2.4 metres (8'-0")
- b) Notwithstanding Section 8.1 a), the maximum height of a fence located within 7.6 metres (25') from the front lot line shall not exceed 1.2 metres (4'-0")

Sight Triangles

Notwithstanding any other provisions of the By-law, no person shall, within a Sight Triangle, as defined herein, erect or cause to be erected a Fence which would obstruct the vision of drivers or motor vehicles.

A fence erected in a sight triangle shall not exceed 1 metres (3'-3") in height when constructed of solid materials and does not exceed 1.2 metres (4') in height when constructed of open materials.
